Coach Minnis recently became the winningest coach in Harvard water polo history for both the men's and women's programs. On the men's side, Minnis won his program-best 100th game on the opening day of the 2016 season against then-No. 10 UC Davis. Minnis and the Crimson finished with an overall record of 27-7, pushing his total to 125 victories. He is also the all-time leader in wins for the women's water polo program with 111 total wins, surpassing Chris Hafferty's total of 81 wins during the 2014-15 campaign. Minnis is a veteran coach at the Stanford Club. During his 10-plus years of service, he won two Junior Olympic bronze medals, a U.S. Club Championship and finished among the top 10 at various national tournaments numerous times. Minnis served as the head coach for the Olympic Development Program Pacific Zone for three years and in 2009 worked with the National Youth team staff. Most recently, his teams picked up a pair of silver medals at the 16 and Under Olympic Development Regional Championship and Zone Championship. In 2007, Minnis was named the USA Water Polo Development Coach of the Year and in 2005 and 2007 was a Positive Coaching Alliance finalist for coach of the year.

## Release of Liability

I am the parent or legal guardian of the child named below. My child and I desire that my child participate in water polo events with PACIFIC NORTHWEST & HAWAII ZONE. We each understand and acknowledge that water polo or any similar sporting event is a “physical contact sport” and an extreme test of a person’s physical and mental limits. As such, participating as an athlete can, and occasionally does, result in injury. Although most injuries are minor, serious and even life threatening injuries or death can occur. With full understanding of these potential risks, we assume the risks of participating in PNWH ZONE events.

My child and I, therefore, each (i) release PACIFIC NORTHWEST & HAWAII ZONE and it’s coaches, officers, directors, chaperones, tournament directors, employees, sponsors and agents (each a “PNWH Party”) from any and all claims, liabilities, obligations, costs and expenses arising from personal injury, death or damages of any kind, except those which result from gross negligence or willful misconduct of the PNWH Party, (ii) agree not to sue any PSPC Party for any of the claims, liabilities, obligations, costs or expenses that we have released and (iii) agree to indemnify and hold harmless each PNWH Party from any claims made or liabilities assessed against him, her or it because of my actions or actions of my child.

I execute this Release for and on behalf of myself and my child. I hereby bind myself and my child and the guardians, personal representatives, heirs, successors and assigns of each of us to the terms of this Release. I represent that I have legal capacity and authority to act for and on behalf of my child. I agree to indemnify and hold harmless each PNWH Party from any claims, liabilities, obligations, costs or expenses assessed against him, her or it as a result of any insufficiency of my legal capacity to act for and on the behalf of my child in the execution of this Release.
